Capel in his capacity as an expert for the purposes of assisting counsel for PWGSC in understanding and commenting, if needed, on the evidence comprised in Mr. Stephen Beaudoin's affidavit dated October 13, 2000. This disclosure is subject to the following conditions:

- 1. Mr. Capel will execute the attached Undertaking and Acknowledgment. Counsel for PWGSC, Mr. David Attwater, will countersign the said document to acknowledge that Mr. Capel is working under his direction and control.
- 2. Mr. Capel shall have access to the protected record at the Ottawa offices of the law firm of Lang Michener.
- 3. Mr. Capel shall, under the conditions of his Undertaking and Acknowledgement,
  - use the information disclosed exclusively for purposes of the subject proceeding;
  - not divulge information disclosed to any person for any purpose;

- not reproduce, in any manner, information disclosed; and
- return to the Secretary of the Tribunal any notes, tables and memoranda created based on that protected document.
