AND FURTHER TO a decision of the Canadian International Trade Tribunal to conduct an inquiry into the complaint pursuant to subsection 30.13(1) of the *Canadian International Trade Tribunal Act*;

AND FURTHER TO an order issued pursuant to subsection 30.13(3) of the *Canadian International Trade Tribunal Act*;

AND FURTHER TO the withdrawal of the complaint by Beyond Technologies Consulting Inc.

ORDER

WHEREAS the above-mentioned complaint was filed on November 11, 2019, by Beyond Technologies Consulting Inc.;

AND WHEREAS the Canadian International Trade Tribunal decided, on November 13, 2019, to inquire into the complaint, pursuant to subsection 30.13(1) of the *Canadian International Trade Tribunal Act* and subsection 7(1) of the *Canadian International Trade Tribunal Procurement Inquiry Regulations*;

AND WHEREAS, on November 13, 2019, the Canadian International Trade Tribunal ordered, pursuant to subsection 30.13(3) of the *Canadian International Trade Tribunal Act*, that the Department of Foreign Affairs, Trade and Development postpone the award of any contract in connection with the current procurement until the Canadian International Trade Tribunal determined the validity of the complaint;

AND WHEREAS, on December 10, 2019, the Department of Foreign Affairs, Trade and Development filed its Government Institution Report in response to the above-mentioned complaint;

AND WHEREAS, on December 12, 2019, Beyond Technologies Consulting Inc. informed the Canadian International Trade Tribunal that it was withdrawing its complaint;

AND WHEREAS subsection 30.13(5) of the *Canadian International Trade Tribunal Act* provides that the Canadian International Trade Tribunal may cease conducting the inquiry;

THEREFORE, pursuant to subsection 30.13(5) of the *Canadian International Trade Tribunal Act*, the Canadian International Trade Tribunal hereby ceases its inquiry;

AND, THEREFORE, the postponement of award of contract order issued on November 13, 2019, is hereby rescinded. Each party will bear its own costs in this matter.
